#### 2. OPSRRA MEMBERSHIP MEEETING

# 3. UPDATE ON DISRICT OF SOOKE'S PROPOSED ANNEXATION OF OTTER POINT PROPERTIES

The District of Sooke has submitted a formal request to the province to annex properties along the District's border with Otter Point and East Sooke (see July's newsletter for maps and details). OPSRRA has met with John Horgan, our MLA, to discuss the situation and we have requested his assistance in arranging a meeting with the provincial Ministry of Community Services. We sent letters to the minister of Community Services in March and again in June asking for such a meeting, We have not received a reply. OPSRRA has also met with other community groups in Sooke, East Sooke and Shirley who feel that their communities will be affected by the proposed annexation.

#### 4. MEETING WITH PROVINCIAL MLA

A delegation of OPSRRA directors met with our provincial MLA John Horgan on July 11 to discuss five OPSRRA concerns:

- The on-going matter of the District of Sooke's pursuit, in cooperation with the province, of the annexation of properties along the Otter Point/Sooke border.
- The refusal of the minister of Community Services to fund a governance study for the Juan de Fuca Electoral Area.
- The acquisition of crown land in Otter Point for a Pioneer Park on the site of the old Otter Point School.
- Realignment of the boundary or a change of the polling station location for Malahat-Juan de Fuca Poll 068A.
- The application, by Chew Excavating, to have their Shirley soil removal permit application renewed by the CRD.

# 5. UPDATE ON RENEWAL OF CHEW EXCAVATING SOIL REMOVAL APPLICATION

Brenda Mark prepared the following report. Brenda is an OPSRRA member and one of the property owners in Shirley who organized the community effort to have the Chew Excavating soil permit removal extension application reviewed by the CRD.

Chew Excavating had Soil Removal and Deposit Permits issued July 25, 2005 to complete the work authorized under their original permits. These extensions expire October 31, 2005 and it's stated that the amount of material to be removed, and deposited, is more limited than was originally intended. There is an Irrevocable Letter of Credit of \$50,000 as well as the usual amount required by the CRD bylaws - (\$4000 and \$1500) as Security Deposits. The permits are also subject to the agreement reached by the CRD, a volunteer committee representing Shirley residents, and Chew Excavating.

The compromise agreement was reached after a number of meetings. On July 4, six residents and a representative from both SEAS and OPSRRA met

with CRD staff. On July 11, there was a public meeting at the Shirley Hall with residents, CRD staff, the regional director and Chew Excavating (the local MLA also attended). On July 18 the Shirley committee met with CRD staff and Chew Excavating to reach a tentative agreement. On July 19 the committee met on-site with CRD staff and Chew Excavating to do a walk-around and identify problem areas and discuss courses of action. The agreement states:

- There will be no further blasting or crushing.
- Safe and considerate driving practices of trucks, hauling material to and from the site is required, including minimal use of 'Jake brakes'.
- There is a 30-day provision for remediation only after October 31, 2005.
- A \$50,000 Irrevocable Letter of Credit to be provided to the CRD, to be held for 1 year to ensure all agreed upon remedial work is completed and any problems corrected.
- Silt control problems addressed and the access road for Lots 3 to 11 repaired by September 15.
- All slopes brought into compliance with CRD bylaws by October 31, with priority for closure and capping assigned to areas where slippage may damage off-site properties.
- Chew will make every effort to have hydro-seeding completed by September 30.
- Natural drainage patterns will be restored to creeks, converting from point flows to sheet flows in the areas identified in the walk-about, with this work being carried out under the supervision of qualified engineers.
- All replanting will be natural in character and the replanting of trees and other vegetation, including the creek beds, will be defined by an environmental consultant engaged by Chew. The consultant's report will be made available to the community representatives.
- Notice is to be given to the Province, under Section 9 of the Water Act, by Chew Excavating, if any of the work undertaken requires that.

# 6. UPDATE ON THE OTTER POINT & SHIRLEY/JORDAN RIVER OCP & ZONING BYLAWS

#### **Shirley/Jordan River:**

The Shirley/Jordan River Official Community Plan (OCP) has been approved by the JDF Land Use Committee and now will go before the CRD Board and the province for their approval before becoming a bylaw.

#### **Otter Point:**

The Otter Point OCP is going for a third public hearing on Tuesday, August 2 at 7:00 p.m. at the Otter Point Fire Hall. This third public hearing was made necessary because outdated maps of the proposed Settlement Areas were still being circulated by the CRD prior to the second public hearing.

Both Zoning committees have finished the first phase of their public meeting. The chairs of the 4 zoning committees (Malahat, East Sooke, Shirley/Jordan River, and Otter Point) will be meeting with the CRD Planning Staff and the regional director to review the outcomes of the public meetings and to decide whether further public meetings are needed. While the Shirley/Jordan River Zoning committee appears to have finished their draft, the chair of the Otter Point committee has indicated that further meetings will certainly be needed in Otter Point.

#### 7. FIRE BURNING SEASON

Residents of Otter Point & Shirley should be aware of the local open burning restrictions in our area.

Despite the wet spring and late start to summer weather, we are in Fire Season and the present rating is **HIGH**. The province has introduced Category 2 open fire restrictions as of July 30. This means absolutely no open burning with the exception of small campfires.

# Otter Point Burning Regulations

The following is summary of the 1958—Fire Regulation Bylaw No. 1, 1991 http://www.crd.bc.ca/bylaws/fireprotection /index.htm

No open burning shall take place during the months of July, August and September.

No open burning between sunset of one day and sunrise of the next day.

Fire season is April 15 to June 30 and October 1 to October 15.

The season may be extended at the discretion of the Fire Chief.

All open burning requires a permit from the fire department: call 642-6211.

As this is a volunteer department, please leave a message and the person issuing permits will call you back.

#### **Prohibited Materials**

The following shall NOT be burnt:

Tires plastic

drywall paint and paint products treated lumber asphalt, asphalt products rubber fuel and lubricant containers

tar paper railway ties

manure.

No person shall ignite or maintain a fire on the foreshore:

- within 46 meters of any building;
- within 3 meters of any driftwood, dry vegetation, grass or any other combustible materials;
- or without obtaining a Class "B" burning permit.

Class B limits on hand pile burning shall be maximum diameter 2 metres or 6 feet.

No green debris or leaves shall be burnt except by specific exemptions which may be at the discretion of the Fire Chief

#### SHIRLEY VOLUNTEER FIRE DEPARTMENT

#### **Burning permits:**

Class "A" (machine piled burns) require a permit at all times. No Class A fires permitted 15 April to 15 October.

Class "B" (hand-built burn piles) require a permit from 15 April to 15 October.

No Class "B" permits will be issued from 15 May to 15 October due to dry soil conditions.

Class "C" fires (incinerators with 1/4" mesh screen) require no permit.

Class "C" fires, at present, have no restriction on burning.



Remember to check your smoke and carbon monoxide detectors regularly (both battery and hard-wired).

#### 8. Juan de Fuca Electoral Area Enumeration (Voter Registration)

The Capital Regional District intends to update the List of Electors for the Juan de Fuca Electoral Area for the 2005 local government elections. **The census will take place between June 29, 2005 and August 5, 2005.** 

You will be contacted, either in person or by telephone, to ascertain whether or not you are eligible to be registered as an elector.

In order to qualify as a Resident Elector you must be a Canadian Citizen, 18 years or older, must have resided in British Columbia for the past six months and within the boundaries of the Juan de Fuca Electoral Area for the past 30 days prior to registration.

The Juan de Fuca Electoral Area consists of: East Sooke, Otter Point, Shirley, Jordan River, Port Renfrew, Malahat, Willis Point and the Songhees and Esquimalt Indian Reserve lands.

# 14. UP-DATE ON THE CIRCLE ROUTE FROM PORT RENFREW TO LAKE COWICHAN

The province has been working on portions of this old logging road from Port Renfrew to Lake Cowichan, in an effort to make it an all season's circle route. As of July 27 the following changes are noticeable:

- Storm water drains have been installed under the roadway at critical locations.
- The road has been widened in some areas past Lizard Lake.
- Gravel has been put-down on the Lizard Lake Lake Cowichan portion.
- Grading and widening is still in progress.

Note: This is still a rough road and although an enjoyable trip, it is still a "bone shaker"! If you go, be sure to stop in Port Renfrew for a look-around and a snack—they have some great places to eat.
