## 2. SOME OF US GOT TO VOTE CLOSER TO HOME

Many residents of the eastern end of Otter Point were able to vote at the Otter Fire Hall in the May 12 provincial election. This was a change from the 2005 election when they were sent to vote at Sassenos Elementary School on the east side of Sooke. OPSRRA brought this matter to the attention of our MLA and Elections B.C. following the 2005 election and were successful in lobbying for a return to the local fire hall as the logical voting place for those residents. The reason that the shift was made to Sassenos Elementary in 2005 was to “balance” the population in a Poll that included residents at the north end of Glintz Lake Road and Sooke River

Road in Sassenos. Hopefully they were accommodated elsewhere in the May 12 election and didn't have to travel to Otter Point to vote!

### **4. OPSRRA SUPPORTS PROTECTION OF MUIR CREEK**

OPSRRA sent the following letter to the Minister of the Environment and the Chair of the CRD Parks Committee with copies to our Regional Director and MLA. OPSRRA directors encourage others to write in support of the Muir Creek Protection Society's efforts to protect Muir Creek and its watershed as park land.

---

I am writing on behalf of our association to request that the province continue to work with all parties concerned to see that the Muir Creek watershed be protected. Muir Creek runs between the two rural communities of Shirley and Otter Point and has been the location for recreation, social events and commerce over this area's long history. Preservation of the creek and its watershed would mean different things to different groups; but to our community it would mean the protection of one of the most significant natural areas west of Sooke and one of the few places along this section of the coast where you can easily access the ocean.

Water and wildlife conservation were identified as important environmental strategies by the community in a recent project to help identify a strategic vision for our area. One of the suggested ways to do this was to acquire conservation areas, parks, waterfront parks, beach access and trails. Muir Creek was specifically mentioned in the report because it has the natural geography to capture all of these conditions. I have attached a copy of the project's final report: Developing a Strategic Vision for Otter Point, Shirley & Jordan River and refer you to page 8, item 3.

Our association wishes to see development in our area happen in an orderly manner and in the best interests of its residents. Protection of important watersheds and creeks such as Muir Creek from development is a start.

**5. SOOKE REGION MUSEUM PREMIERES HISTORICAL FILM FOOTAGE AT JUNE OPEN HOUSE**

The Sooke Region Museum recently received a donation of historical film footage from 1927. Included in the material are wonderful scenes from the local area including the flume at Jordan River, the Fish Traps and the Belvedere Hotel that was situated on a headland at the mouth of the Sooke River on Sooke Basin; behind where the present Sooke River Hotel (Castle) pub and restaurant are now located. Other historic footage includes views of the Crystal Gardens, located behind the Empress Hotel in Victoria and Butchart Gardens in Brentwood Bay.

The museum has made special arrangements for the public to see the historical film footage at its annual Open House on Sunday, June 28. Viewings will start at 10:30 a.m. in a special tent on the museum grounds and will continue through-out the day until 4:00 p.m.

Starting at noon the Open House will feature a traditional salmon BBQ (slow smoked salmon over an open alder wood fire), music from the Blue Grass Festival, exhibits and other activities for all ages.

**6. THE KEMP LAKE WATERWORKS DISTRICT**

The Kemp Lake Waterworks District held its Annual General Meeting on May 20. The Kemp Lake Waterworks District is an organization that is essential to the daily life of many Otter Point residents. However, perhaps because it quietly goes about its business and does it well, it doesn't get very much public attention.

Here are a few facts about the Kemp Lake Waterworks District:

- It was established in 1953 through the Water Act of British Columbia.
- It provides community water over a water district area of 1.44 square miles in Otter Point to approximately 444 residences.

- It draws water from Kemp Lake and distributes it to water district residents through a system of two reservoirs, two pumping stations and approximately 10 kilometres of piping.
- It uses a chlorine treatment to kill bacteria in the water, which is tested monthly from several locations by Vancouver Island Health Authority inspectors.
- It funds its services through an annual tax to water district residents and additional service charges every two months based on the volume of water used.
- It has assets of approximately \$1,422,710 in waterworks equipment and an annual operating budget of approximately \$118,000.
- It is governed by a board of three elected trustees who must be landowners in the district (Kevan Brehart, Joanne Hemphill, Richie Birch).
- It maintains a website ([www.kemplakewaterworks.bc.ca](http://www.kemplakewaterworks.bc.ca)) where information is available about a range of issues, including various planning studies commissioned by the trustees.

## **8. SEAPARC RECREATION COMPLEX EXPANSION SURVEY**

The Sooke & Electoral Area Parks & Recreation Commission (SEAPARC) recently sent-out a householders survey requesting comment on a proposed expansion to the Leisure Complex on Phillips Road in Sooke. Taxpayers in both the Electoral Area and the District of Sooke pay a proportional amount towards the operation of this community recreation facility. The proposed expansion is to add a weight room/fitness area; an aerobics and fitness class area; additional dressing rooms for

the arena and program space for staff. The estimated cost would be \$2.7 million dollars based upon 2008 estimates. Perhaps 1/3 of this cost (about \$1 million dollars) would come from taxpayers; possibly in the form of a tax increase. This increase is estimated to be \$11.00 per year on an average-cost home in the Juan de Fuca Electoral Area.

## **9. RESOURCE LANDS OFFICIAL COMMUNITY PLAN & LAND USE BYLAWS GO TO ADVISORY PLANNING COMMISSION (AGAIN)**

There were so many recommended changes to the first draft of the Rural Resource Lands Official Community Plan (OCP) and Land Use Bylaws that the Planning Department suggested to the Juan de Fuca Electoral Area Land Use Committee (LUC) that the original draft bylaws be rescinded and that new draft bylaws be given first reading and sent-out for another round of comments. LUC agreed to this at their May 19 meeting. The next round of APC meetings to review the revised proposed drafts is tentatively scheduled for the week of June 22. Dates and locations will be advertised in the Sooke News Mirror.

A representative from OPSRRA spoke at the May 19 LUC meeting in support of the bylaws being sent to the community for a second round of comment and expressed appreciation to the Planning Department for the manner in which the information from the first round of community comments had been organized and included in the revised bylaws. The matter of whether residents of Shirley and Otter Point—and OPSRRA—should even care about what happens in the Rural Resource Lands has been raised. Here are some reasons to be interested in what may happen with the future of these lands, as could be determined by the proposed OCP and Land Use bylaws.

- The Rural Resource Lands borders onto our communities and in some cases are right against existing residential areas.
- There are two important development proposals already pending for this area. One is referred to as the Brown's Mountain development which is adjacent to Port Renfrew and the other is the Ilkay/Marine Trails Holdings development west of China Beach and bordering the provincial Juan de Fuca Marine Trail.

- The present minimum size for subdivision in the Rural Resource Lands is 120 hectares. Advocates for the release of resource land for residential development are lobbying for changes to the proposed Rural Resource Lands OCP and Land Use Bylaws to allow for smaller lot sizes. These smaller lot sizes, if approved, may impact the Otter Point and Shirley/Jordan River OCPs which are scheduled to come-up for review this fall.

- The major portion of the Western Forest Product's private forest lands that the provincial government removed from Tree Farm License (TFL) 25 two years ago are in the Rural Resource Lands. A smaller portion is in the Shirley/Jordan River and Otter Point OCP areas.
- Otter Point, Shirley and Jordan River and the Rural Resource Lands all use Highway 14 as their major transportation route.
- Highway 14, west of Muir Creek, passes through the Rural Resource Lands in the vicinity of Blueberry Flats.
- Two Run-of the River power project applications are pending: one at Rosemond Creek, just west of China Beach Provincial Park and the other at Uglow Creek, just above China Beach Provincial Park.
- In the past, the private forest lands in the Rural Resource Lands area have been a source of significant taxation revenue for the Juan de Fuca Electoral Area, which has helped to offset our residential taxes.
- Significant residential and recreational development in the Rural Resource Lands will lead to increased requirements for fire fighting, emergency, policing, transportation and other CRD and provincial services. Such increased service costs are likely to be paid for by all Juan de Fuca taxpayers through increased property taxes.

## 10. DID YOU KNOW THAT ...

**Railways were a common means of transportation throughout the area from Sooke to Port Renfrew about 100 years ago?** They were used to move logs, equipment, supplies and logging crews for several decades from the early 1900s to the 1930s.

The first Sooke logging railway started as early as 1907. By 1912 the Canadian & Panama Timber & Logging Company was building a line along DeMamiel stream towards the present day Otter Point. In July, 1917 the Sylvania Logging Company began operating a railway from Sooke to Otter Point to service its three logging camps (Helgesen Road at Otter Point Road, Poirier Lake at Young's Lake Road and Tugwell Road at Goudie Road). Much of present day Tugwell Road is built over their old railway line.

A proposed railway from Point-No-Point, in Shirley, west to Jordan River was planned in the 1920s but never went ahead—likely because this was a time when larger trucks were coming into use which could be used to haul larger loads thus replacing the more expensive railways. In 1922, Milligan's Logging introduced the first Leyland trucks on Vancouver Island to their Shirley operation. They built five miles of plank road using 40-foot lengths of six-inch by 10-inch thick planks cut at their Shirley mill. The road ran from their logging operation to a log dump site east of Sheringham Point Lighthouse. The trucks had eight-foot long beds or bunks and sometimes could carry only one log because of the size of the trees that they were logging. Rotting remnants of the plank road can still be found in the bush.
