5.3 JDF Governance

Nothing back from Ministry staff assigned to work on a report. CRD Planning Services recommended changes to who could vote on JDFEA land use matters. The Otter Point OCP will go to the CRD Planning and Protective Services Committee to determine if it is consistent with the RGS. If not, the process stops until it meets the requirements and the will go to the full CRD Board for approval.

Fiona mentioned the letters to the Sooke News Mirror regarding the JDFEA not having a dispute resolution process under the RGS

5.4 JdF Building Update

The proposal is going to LUC tomorrow and then to the Otter Point APC. CRD Board has approved the proposal with \$1.5 million from the CRD Building Fund. The three corner properties are subject to re-zoning from M-2 to P4 (Public Institutional). This proposed zone would permit office, assembly and civic uses related to the JDFEA services as well as potential community uses such as retail and a restaurant. It was agreed that a representative from OPSRRA will speak at the Public Hearing.

5.5 OPSRRA Surveys

Sandy has sorted the responses from our surveys and has posted them to the website. We will be presenting the water survey in January. We discussed some ideas for the Community Services survey.

There has been a special meeting planned for Dec 4, 2012 to discuss the future of the EDC, with considerations about the cost of administration, advertising, cheque writing etc.

Route will be in newspaper

7.17 Shirley Volunteer Fire Department

Fire Commission AGM is November 25. There are 3 positions up for election. The radio tower is up. The Shirley Fire Protection Society AGM is December 9. There is one position up for election. The Shirley Fire Department has a new \$60,000 First Response vehicle. The Oct 23 Commission meeting went well; there was resolution to the concerns regarding the resignation of the former Fire Chief.
